The land within the District is generally located west of the Lake Worth Drainage District Canal E-4, east of Congress Avenue, north of Old Boynton Road and south of South Florida Water Management District Canal C-16.</p> <p>The Creekside at Twin Creeks CDD is also authorized to exercise additional powers to finance, fund, plan, construct, reconstruct, enlarge or extend, equip, operate and maintain systems and facilities for 1) parks and facilities for indoor and outdoor recreational cultural and educational uses; and 2) security, including but not limited to, guardhouses, fences and gates, electronic intrusion-detection systems, and patrol cars, as authorized and described in Section 190.012(2), Florida Statutes (2014).</p>
